

MORE ABOUT YOUR CCDF PAYMENTS & PROGRAM

CCDF Subsidy: Your total CCDF subsidy is calculated based on your co-payment total and the local reimbursement for the program you have selected. The maximum reimbursement total is based on your county's average cost of child care and your program's Paths to QUALITY level. Programs at higher Paths to QUALITY levels are reimbursed at higher rates.

CCDF Co-Payment: Your CCDF co-payment is the amount of money that you are responsible for paying to your selected program. This amount is based on your family's income, the size of your family, the amount of time you have received CCDF vouchers and the current standard Federal Poverty Level. You can find this total on your voucher. You are responsible for paying this amount directly to your selected program.

CCDF Overage: If a provider's charges are higher than the local reimbursement rate, any overages may be charged to the family for the CCDF voucher.

Paths to QUALITY™: Paths to QUALITY™ is Indiana's statewide quality improvement rating system for early care and education programs. It is a resource to help families make informed decisions and to help programs improve quality. It is a voluntary system that consists of 4 levels. Level 1 meets the health and safety needs of children. Level 2 focuses on providing environments that supports children's development and learning. Level 3 incorporates use of a planned curriculum to guide child development and prepare children for kindergarten. Level 4 is the highest indicator of quality, National Accreditation. Programs can earn incentives when progressing in levels; these incentives can contribute to enhanced quality. Advancement of levels within the Paths to QUALITY™ system demonstrates a commitment to supporting children's development, learning, and future success in school and life.

Child Care Facility - Unlicensed Registered Child Care Ministry PTQ Level 4



You have chosen an accredited registered ministry that is also on Paths to QUALITY™, Indiana's quality rating and improvement system. Registered ministries are not licensed, and they may or may not use a faith-based curriculum. While your program is not licensed, they have chosen to be in the state's "voluntary certification program" (VCP).

Your chosen program has achieved a Level 4 in Paths to QUALITY™, Indiana's quality rating and improvement system for early care and education. Programs at Level 4 meet additional basic health and safety standards, offer an environment that supports growth and learning, follow a planned curriculum, and have been accredited by a national organization.

Your selected program has chosen to participate in Indiana's Voluntary Certification Program for child care ministries. In Indiana, an unlicensed registered ministry meets basic health and safety standards or can choose to demonstrate greater commitment to quality through participation in the Voluntary Certification Program. Once a ministry has achieved Voluntary Certification Program status, they are automatically eligible to enroll on Paths to QUALITY. Paths to QUALITY is Indiana's quality rating and improvement system. Programs reaching Voluntary Certification Program status meet additional health and safety standards that other registered ministries may not.

Your selected program is accredited by a national accrediting body. Accredited programs fulfill several quality requirements. Typically, these requirements include staff training and education, family engagement, clear policies, classroom quality, essential health practices, and connections to community resources.

Your program was last inspected on April 26th 2018.
